1. Do not freerun on private property including roofs. No practicing on or over vehicles, no matter where you are.
2. When asked by police or any other people to move on, please co-operate with them. Avoid drawing attention and giving the club a negative image.
3. When wearing team clothing members should be extremely careful where they freerun. Do not use bad language, as you will be representing the club.
4. Only full members of the club who have signed the Code of Conduct and are in agreement with its terms and conditions are allowed to wear official team/club clothing.
5. All members attending gym sessions must have completed a parental consent form.
6. All members agree to treat all equipment with respect and also help clear up after gym sessions.
7. All members are expected to attend open club meetings and the AGM wherever possible.
8. The Nantwich Freerunners has a zero tolerance policy re: drug and alcohol abuse. The Club has a random testing policy in place and all members must agree to take this test if requested to do so by the Child Protection Officer (in agreement with parents/guardians, if under 18 years old).

Any member of the club who breaks the code of conduct will be subject to the disciplinary process:

- First offence – formally recorded verbal warning.
- Second offence – written warning with copy to parents and exclusion from two Sessions
- Final offence - exclusion from club activities for a minimum of six weeks to Be reviewed by the committee.
- Gross misconduct – immediate suspension from the club to be reviewed by the Child Protection Officer.
